- (1) A person is not eligible to be elected as a <u>member</u> of an incorporated <u>association</u>'s management committee if—
- (a) the person has been convicted of an offence—
- (i) on indictment; or
- (ii) summarily and sentenced to imprisonment, other than in default of payment of a fine; and
- (b) the rehabilitation period in relation to the conviction has not expired.
- (2) Also, a person is not eligible to be elected as a <u>member</u> of an incorporated <u>association</u>'s management committee if—
- (a) under the <u>Bankruptcy Act 1966</u> (Cwlth) or the law of an external territory or another country, the person is an undischarged bankrupt; or
- (b) the person has executed a deed of arrangement under the <u>Bankruptcy Act</u> <u>1966</u> (Cwlth), part X or a corresponding law of an external territory or another country and the terms of the deed have not been fully complied with; or
- (c) the person's creditors have accepted a composition under the <u>Bankruptcy Act</u> <u>1966</u> (Cwlth), part X or a corresponding law of an external territory or another country and a final payment has not been made under the composition.
