For newer members not familiar with the reason we hold the Birthday Pairs, the following is an extract from "A History of Toowoomba Bridge Club":

"From 2004 to 2006, the main focus was on raising money which became more imperative after gaining building approval. It is impossible to mention everyone who was involved in this process – because it wasn't just the Management Committee and the multitude of subcommittees. It was every member of the club. Without their support, absolutely nothing would have happened. In 2004, the club had 209 members and \$108,000 in its building fund account and it was estimated the building would cost \$282,000 plus \$50,000 for the fitout and parking. In January 2006, this was revised by a quantity surveyor to \$449,823. The actual cost when the building opened in 2007 was over \$700,000.00. Thank goodness they didn't

know that at the beginning because they probably would have just given up there and then



Clive Berghofer had already pledged to pay for the air conditioning for little or no public recognition and now Glenys was going back to him about the site works. As she was driving out to his office, she kept thinking what can we give him? After all, the club had already

offered him free bridge lessons which he still hasn't taken up. So, as she was putting the proposition about him doing the site works and the club paying him over the next 50 - 100 years, he interrupted her and said, "That's alright". "Pardon?" "That will be alright, get Ray Moore to ring me." Which is why Clive is our Patron."

INSUFFICIENT BID LAW 18D & LAW 27

This is a very common mistake – people either don't see the opponents have intervened or they make their next planned bid without registering that they need to go to a higher level. The opposition need to call the director, however -

- If the next player bids without realising the previous bid was insufficient there is no penalty and play proceeds.
- If you make an insufficient bid, realise your mistake and then try to correct it the Director must be called. Your left-hand opponent can accept the insufficient bid, in which the illegal replacement if withdrawn. If instead LHO does not accept the insufficient bid, then it is withdrawn and your later replacement remains. Restrictions may be imposed on your partner for the withdrawn call (which of course they are not allowed to know about).

OPTIONS FOR THE OPPOSITION after an insufficient bid - the first option belongs to the offenders left hand opponent (LHO):

LHO ACCEPTS THE BID.

The main reason to accept the **insufficient bid** is that it has given your side more bidding space that you won't have if they make the bid good at the next level. It can help you to confirm a fit with partner, or to show a second suit, or to bid No Trumps to show strength and a stopper.

LHO DOES NOT ACCEPT THE BID.

The Insufficient Bid must now be replaced with a legal call. The player can bid anything, including a Pass, but not a double or redouble, except in special circumstances (see below)

- As long as he bids the same suit at the next lowest denomination and it is not a convention or a comparable call, , there is no penalty and the bidding proceeds normally.
- If he changes the suit or passes must pass whenever it is his turn to call. There will also now be lead penalties if he and his partner do not win the auction, become the defenders and have not bid that suit legally.
- If the insufficient bid or the substituted bid was a convention, then his partner must pass throughout the bidding. For example,

East bids 4NT (Blackwood) West answers 4D (insufficient)

Now West has a problem. Because 5D is a convention and doesn't mean diamonds, his partner cannot bid again. Therefore, he has to make the difficult decision as to where they should play. If he thinks they will make 4NT and not slam, he can pass. If they were bidding a suit, say hearts, he has to bid either 5H or 6H. But whatever he bids will be the final bid for his side.

Another example is when a player does not see an opening bid and makes a bid.

North opens 1NT. East has not noticed that North opened and bids 1C which is a convention. His partner is now effectively barred from the bidding. Because 1C does not necessarily mean Clubs, if he and his partner become the defenders and his partner wins a trick, Declarer can forbid the lead of ANY suit.

Club Pairs Championship 2025



The Club Pairs Championship was held on the last three Wednesday Afternoons in July. It was almost a full house both days. The field was divided into two grades (Open and Novice) with the first session being a qualifying round with the top 6 contending pairs in each direction advancing to the respective final. Each final then played 11x5-board rounds against every other pair in their final. This is a fair way to run such a large event "all plays all" – it is called a Barometer Howell. "Barometer" because all boards are played at the same time, so pairs know how well they are doing as they progress – unlike a regular Howell where boards move around the room and no results are known until the end.

Those not in the final played a regular duplicate pairs session, but still for red masterpoints.


Bridgemate Changes

We had major problems in the second session of the Club Pairs Championship Open Final, because two tables entered the wrong table number at the start of the session this then meant that at the end of that round the bridgemate told them to go to the wrong table, and so on. It was compounded because some people went to the "right table" despite the names not matching (or they didn't check) and some to the table that reflected their name despite the move instruction from the previous table. It also meant that the scores at that table X went to the pairs sitting at table Y, and vice versa. I spent most of that night and some of the next morning piecing it all together. I did contact some people to confirm where they sat, and I appreciated those who responded, but did not want to call much after 10:00pm.

Boo boos are a part of life. If only one table had made such an error, then normally the second table would not be able to start their bridgemate and we would have been aware of the problem and could have fixed much earlier. This time it was not to be. Actually "typing the wrong table number into the bridgemate" happens a lot in regular sessions as well - you will often see a Director scurrying to a table during the first round "because their bridgemate doesn't work". An example is three board rounds where table 7 can't start their bridgemate, and it turns out to be because table 3 had just played board 7 and entered this as the table number!

More care and education may help, but I don't see the problem going away so I have acquired more bridgemates and over the next month they will be hard-coded, so players do not have to enter the section nor table number. It will make it easier for the players, but harder for the Directors and helpers who put out and collect the bridgemates.

As an aside, there is a new model of Bridgemate available. It is a full graphics screen so it is easier to read and there is more information on each screen (When you enter the lead it asks "what did Charlie lead" etc). The price that is paid for this graphics is that it is a touch screen with no tactile feedback. The overall functionality is the same, so I don't see a burning need to update in the near future, but it is nice to know what is out Chris there.

Hello Bridge fanatics

These new books on our library shelves, listed below, are not being borrowed and I am wondering why...they are all recent publications. Do you already know too much? Do you have no room in your brain for more information? Are you already such a Bridge expert that you despise any notion of others' ideas? Surely not! Here's a brief rundown of the titles again, to spark your interest, hopefully!

Coming Back to Bridge (Goldfinger), as the name suggests, is written for people who have played Bridge many years previously and now want to explore the current conventions and methods of card play. It's also a geed read for beginners.

2/1 on Steroids (Solow) is written in a very personable style by a mathematician and keen Bridge player who calls his version of 2/1 "M&M" – yes, like those tasty treats. Check it out to find out why!

Twelve Important Bridge Lessons on Declarer Play (Bird) is just that – twelve chapters, each with a recap quiz at the end of each lesson. Chapter one is "When to draw trumps" and chapter three is "When to hold up". Chapter two? Check it out.

Step By Step Playing Bridge Contracts (Berthe & Lébely) is a companion volume to the much older Step by Step Playing Notrump Contracts" and is all about improving your card play. There is a useful index, and the last one third of the book is practice exercises.

Bridge Bidding Tips (Parker) is a great Q&A book, with a chapter of information on a particular bidding tip, followed by a quiz about it. Please don't be tempted to write or circle your answers in the book!

Improvers Lessons

In the next few weeks, we will be checking that it is safe to bid Slam using Blackwood after suit has been called/agreed and Gerber after partner has shown a balanced no-trump call. Our responses are up-the-line, so after 4NT, 5C shows 0 or 4 aces, 5D shows 1, etc; and after 4C Gerber, responses are 4D shows 0 or 4 aces, etc.

If you play with one of these developing players, please use their system so they can practice what they have learnt.

Week 15: 18 Aug is Supervised Play

Week 16: 25 Aug is Slam Bidding Notrump Contracts – 4C Gerber

Week 17: 1 Sept is Supervised Play

Week 18: 8 Sept is Opening Strong Balanced Hands

Week 19: 15 Sept is Supervised Play

Week 20: 22 Sept is Opening Strong Unbalanced Hands

Winners are Grinners

The "Monthly Winners" are recognised as the "individual" winner of <u>eclectic</u> multi-session events. These events combine of all the green masterpoint sessions in a month that have not already counted toward a competition. If there are three available sessions then your best two scores are counted (shows as 2/3), if there are four available sessions then your best three scores are counted (3/4) and if there are five available sessions then your best four scores might be counted (4/5). If there are two available sessions, then they are treated as an eclectic event (best 2/2). If there are five days in the month, then we usually combine two of these (see the bridge diary) as a "<u>Two-Weekly</u>" and additional masterpoints are awarded to the top half of those whose partnerships played both days. The remaining three days are scored as an eclectic with (2/3).

Session Rules Reminder

- Players should be <u>seated</u> 15 minutes prior to the start of play for a session.
- The Director makes the final decision on seating arrangements and on playing arrangements in the room (e.g. windows, air-conditioning).
- Only **green** and **blue** systems are permitted in club events.
- System cards are compulsory for competitions and red master point events and strongly recommended for all other sessions.
- NS are primarily responsible for the playing conditions at the table (bridgemates, management of boards and moving them if instructed to do so by the Director).
- EW are primarily responsible for tidy up and leaving the table in a good condition ready for the next session.
- All players should offer to help with general room clean-up to assist the Director.
- No notices are permitted on the noticeboards unless approval is given from the Management Committee.
- No trading is permitted on the club premises unless written permission is given via the Management Committee.
- Smoking is only permitted in the Designated Smoking Area or in the parklands off the premises.
