WHY BECOME A COMMITTEE MEMBER?



Whilst our AGM is not scheduled until 24 October 2015, it is probably time for members to start thinking about nominations for Committee.

People come up with lots of reasons why they should not go on Committee; "Haven't got the time"; "I only come to play bridge"; "Don't need the agro"; "I would tell them what I thought of them"; "Too old"; "Can't be bothered with all that rubbish"; "Not interested" are some of the comments I get from people. But without a Committee there is no club.

With Keith not running for President again, and my husband making me promise not to do the Secretary's job (because he knows I will keep doing everything else I do), we all need to start thinking about our next Committee.

While the President's job is notionally to run the meeting and make sure office bearers have the help they need, his or her main responsibility is to make sure the club abides by the Rules and By-Laws. Some members seem to have an unrealistic expectation that the President is there purely to hear their complaints and fix things. Well actually that is the job of the committee as a whole.

The Secretary's job now needs three people to make it manageable. AGM NOMINATION FORMS

Nomination forms for Committee positions are now available from the Secretary. All nomination forms will be displayed on the Notice Board near the dealing room.

- (a) Any 2 members of the association may nominate another member (the candidate) to serve as a member of the management committee;
- (b) the nomination must be:
 - (i) in writing;
 - (ii) signed by the candidate and the members who nominated him or her; and
 - (iii) given to the secretary at least 14 days before the annual general meeting at which the election is to be held.

Nominations close two weeks before the meeting. Each candidate must be nominated by two members, with all three signing the nomination form.

ELIGIBILITY FOR COMMITTEE

- (1) A person is not eligible to be elected as a member of an incorporated association's management committee if:
 - (a) the person has been convicted:
 - (i) on indictment; or
 - (ii) summarily and sentenced to imprisonment, other than in default of payment of a fine; and
 - (b) the rehabilitation period in relation to the conviction has not expired.
- (1A) Also, a person is not eligible to be elected as a member of an incorporated association's management committee if:
 - (a) under the Bankruptcy Act 1966
 (C'wlth) or the law of an external territory or another country, the person is an undischarged bankrupt; or
 - (b) the person has executed a deed of arrangement under the Bankruptcy Act 1966 (C'wlth), part X or a corresponding law of an external territory or another country and the terms of the deed have not been fully complied with; or
 - (c) the person's creditors have accepted a composition under the Bankruptcy Act 1966 (C'wlth), part X or a

corresponding law of an external territory or another country and a final payment has not been made under the composition.

(2) In this section, rehabilitation period has the meaning given in the Criminal Law (Rehabilitation of Offenders) Act 1986.

In the Zone

Queensland Open Teams

Eight teams from Goondiwindi, Warwick, Dalby, Darling Downs and Toowoomba clubs competed in the Zone Qualifying Heat of the Queensland Open Teams hosted by Warwick Bridge Club on Sunday 21st June. The top two teams have qualified for support to play in the State Championship at Toowong on 22-23 August:

Queensland Open Pairs

Players from all zone clubs can play in the qualifying event to be held on Sunday 20th September hosted by the Toowoomba Bridge Club. The top two or three pairs will then be supported to play in the State Championship on 17-18 October.

Grand National Open Teams

The GNOT is an Australia-wide teams competition playing for glory and for gold master points. Each club runs a qualifying round early in the year to qualify a team(s) to play in a Zone/Regional Final. The winner from the Zone Final is then given some financial support by the ABF to play in the GNOT Final, which is held in Benowa Point at the end of November. Sixty-four teams from all around Australia play in the final.

Our Club Qualifier of the GNOT will be held on Sunday 6th September, and all players are welcome.

The Darling Downs Zone is comprised of the Dalby, Darling Downs, Goondiwindi, Lockyer, Roma, Stanthorpe, Toowoomba and Warwick Bridge Clubs. The Zone Final will be hosted by Dalby on Sunday 25th October.

Policy of Zero Tolerance of Poor Behaviour

Law 74 of the Laws of Duplicate Bridge covers the very important area of Conduct and Etiquette.

[Law 74A] gives examples of **proper attitude**.

- 1. A player should maintain a courteous attitude at all times.
- 2. A player should carefully avoid any remark or action that might cause annoyance or embarrassment to another player or might interfere with the enjoyment of the game.
- 3. Every player should follow uniform and correct procedure in calling and playing.

[Law 74B] gives guidance on **etiquette**.

As a matter of courtesy a player should refrain from:

- 1. Paying insufficient attention to the game.
- 2. Making gratuitous comments during the auction and play.
- 3. Detaching a card before it is his turn to play.
- 4. Prolonging play unnecessarily (as in playing on although he knows that all the tricks are surely his) for the purpose of disconcerting an opponent.
- 5. Summoning and addressing the Director in a manner discourteous to him or to other contestants.

[Law 74C] gives examples of **violations of procedure**.

Law 74A covers all facets of **unacceptable behaviour** at the table. It might be where an opponent gloats over "scoring a top against you", making a disparaging remark if you make a mistake at the table, cursing at you if you "dare to call the Director", etc. The Toowoomba Bridge Club also has local By-Laws that give further examples of poor behaviour:

- 1. Criticising partner or opponents.
- 2. Badgering, rudeness, insinuation, profanity, threats of violence, violence.
- 3. Negative comments concerning opponents' or partner's play or bidding.
- 4. Discussing hands after the round is called.
- 5. Objecting to a call for the director.
- 6. Disputing a Director's ruling during the game.

If poor behaviour occurs at your table and it interferes with your enjoyment of the game, then you should quietly but firmly call the Director immediately. The best time to address such problems is while all parties are present.

- (1)If the Director is satisfied that a breach of the policy has occurred during session time, then the offending player will be fined (eg their score for the session reduced) by 25% of a top on a board. This non-discretionary penalty equates to approximately 1% in the session. These penalties are a part of bridge and are covered by Laws 74 and 91. If a player commits a third offence at the same session then the player will be removed from the session and sent home. Any decision of the Director may be appealed (Law 92) but an appeals committee may not overturn a disciplinary penalty. They can, however, suggest that the Director change his ruling. We hope it never comes to this, but our policy covers the situation just in case.
- (2) If the issue cannot be resolved to either party's satisfaction during or at the end of the session, the Director will inform them that they have 48 hours after the end of the session to put their allegations in writing to the Secretary. The Director will provide them with a copy of a Conduct Report Form to assist them to do so.
- (3) If one or more members wish to make an allegation about the conduct of one or more other members regarding offences that are not directly related to a session of play, then that allegation shall be made in writing to the Secretary within 7 days of the incident occurring.

In both of these cases, the Secretary, acting on behalf of the Management Committee may initiate a review concerning the conduct of any member of the Club. See By-Law 5 for further details.

"Writing a letter" after you get home is rarely a good idea – so please call the Director and let the club procedures take care of the situation.

Please enjoy your bridge, and "play nice".

Hand Evaluation by Edwin Willey

South passes, and as West you hold SJT9764, H6, DKJ72, CJ8. Spades are short of top honours, but they are solid, and you just love your side suit. So despite being vulnerable to non-vulnerable, you bid 2S (weak); it describes your values well, and

you steal two levels of auction. Regardless, you do have the minimum values your partner expects, and if partner has values they will mostly over the opponents best hand (North).

North bids 3D. Well! You have/had(?) a surprise in store! And partner now raises you to 6S!!

East now know that West has a singleton Heart and, unless also holding a singleton Diamond (which is doubtful), has a useless DK. So 12 tricks will depend on finding the SQ with North.

Returning to the actual auction: in this case, East has extra information about the position of outstanding points. West guaranteed SIX points, East has TWENTY; so North must have most the remainder. West could have asked for controls, but did not, going confidently to 6S. The grand slam only depends on West holding SAQ; in which event, West should bid 7S, as East has SK.

NOTES FROM COMMITTEE

This is an update on some of the issues dealt with by your Committee and office holders since our last newsletter in April.

RISK MANAGEMENT

Roger Ley was given responsibility for producing a Risk Assessment for the club and as a result of his recommendations the following tasks have now been completed:

- Fencing has now been extended along the southern boundary to minimize the risk of a car going over the edge.
- An evacuation plan is being arranged by Ann Klibbe.
- Safety glasses, dust and chemical goggles, eye wash saline and masks have been purchased for use with the garden maintenance.
- No smoking signs have been put on the verandas thanks to Trevor Glasby who put the signs up (not without some frustrating moments).
- A Chemical Register has now been set up thanks to Chris Snook. This was another involved job that took a lot of time.
- A new first aid box has been purchased, and attached to a wall in the office, with the old one now in the kitchen.
- The Club is waiting for guidelines from the QBA regarding protocols relating to a defibrillator.

GRANT APPLICATION

An application was put in for a Community Grant for hand dryers for the rest rooms and a shed. As we were the recipients of a grant last year, it was not unexpected when this was knocked back. Total cost for two hand dryers is \$3,400 and the cost of a shed is \$4,000 plus.

The Committee will be looking at purchasing these items in the very near future.

- A number of the older shrubs have either been removed or relocated.

- The archway has been repositioned to a more prominent position.

STRATEGIC PLANNING SUBCOMMITTEE

Members of the Strategic Planning Sub Committee are:

Larraine Sutton, Ann Klibbe, Robbie Fulton, Chris Snook, Leonie Spence, Henry Eastment and Keith Jenkin.

This was set up in March with the purpose of evaluating any inherent risks and also growth opportunities for our club, thus enabling the sub committee to draw conclusions and formulate recommendations, which may be useful for the club in planning for the next five to ten years.

They are following the format of the QBA Strategic Plan and will be looking at the key elements of: Membership, Financials, Directing, Teaching and beginners, Management, and Relationships.

The development of a Strategic Plan will identify strengths and weaknesses, how well our club manages these key elements and where there may be opportunities for improvement.

MAINTENANCE

With Adrian and Corry Mayers travelling around Australia, Peter Cory has been fulfilling the duties of Maintenance Co-ordinator in Adrian's absence. This is in addition to helping the Secretary look after the office needs and looking after our sponsors.

Since the end of June, Peter has:

- Organised the Fire Extinguisher inspection.
- Had the plumber up for the men's urinal.
- Had the emergency exit light fixed and bulbs replaced in the emergency lights after arranging three quotes.
- Had 2 meetings with the air-conditioning guys which lasted a total of 5 hours.

When he volunteered to fill in for Adrian, he didn't realise it was going to be almost a part-time unpaid job!

PROTOCOLS FOR REGULATING AIR CONDITIONING

The Director of the Day is the one and only person to regulate the Air Conditioner.

All Directors are to use the sign already in place on the wall adjacent to the switches near the front door, which explains how to set the system correctly. (System should be on manual according to the operating manual)

Unfortunately we are waiting on parts for the East room air-conditioner, which means it is now out of action until the parts arrive. With only one air conditioner working for both rooms, please do not open the windows when it is on as this lessens the effectiveness of the system.

The following are the recommendations given to Peter by a representative of *BNR Refrigeration & Air Conditioning* regarding the optimal operation of the two (East & West rooms) air conditioning units. Based on 30 years experience, he recommended:

- 1. Both units should be operated on <u>Manual</u> settings. On <u>Automatic</u> settings, the air conditioning units are fighting each other and/or draughts when windows are opened while the units are running.
- 2. To obtain the most stable control of air temperature across the clubrooms, both East and West units should have a sensor installed in the return units (ceiling intake units). This is the usual practice undertaken at the time of the AC units' installation, however, these sensors were apparently not installed.
- 3. Both units should have their control units repositioned to be within the Office, so there is minimal risk of adjustment to optimal settings, other than by the sessions' Director, or a Committee member. Currently the Eastern control unit's sensor is adversely influenced by its very poor position in an area that receives minimal airflow, and/or it is hidden under a "half-metre of coats", as is often the case in the Eastern Entrance area. While the control unit in the Western room is in a less than favourable position, being close to a corner with "relatively restricted" airflow, that is not an accurate sample of the room's average temperature, it is significantly better than the Eastern room's control unit very poor placement.
- 4. Airflow should be re-balanced across clubrooms if/when installation of sensors, and repositioning of control units is undertaken.

OUTCOME OF SPECIAL MEETING 30th May 2015 Topic: Goods and Services Tax (GST)/Membership subs

(a) When does GST become a liability for an organisation?

Chris stated that as far as our club is concerned, the trigger for our club paying GST is when the club's income reaches \$150,000 taking into account all income from the previous 11 months plus the current month or the next 11 months plus the current month.

(b) Total amount payable:

Once the club is registered for GST, the total GST payable equals 1/11 of all income from subscriptions, table monies, sponsorship, bridge club related activities. Only donations made at arm's length are not included. Credits can be claimed on GST already paid on expenses.

(c) How much do we spend on members entitlements?

It was calculated that we spend approximately the following amounts on all members irrespective of how many times they come to the club:

AGM Booklet \$5

Newsletters \$5

Birthday Club \$6 (free game, card & postage)

It was moved and carried that the Committee will make a recommendation at the AGM for our membership fee to revert to what it has been for the previous 10 years, namely \$20.
