# **Congress Convenor's Report**

The Toowoomba Bridge Club held two Congresses recently, The Novice pairs on the 27th March and the Toowoomba Pairs & Teams from 30th April to 2nd May 2011. Both Congresses were attended extremely well, with a lot of local support as well as many visitors, particularly from Brisbane, which was really great to see.

There were thirty-eight pairs competing in the Novice Pairs event. Floyd and Majella Wilson jumped out of the blocks and won the morning session with 68.19%. Unfortunately they were run down by players from QCBC and finished in third position overall – a great effort.

Out of the seventy-six players competing, forty-six of these players had fewer than twenty-five masterpoints. It was really great to see such a large number of relatively new players entering the Congress and prepared to have a go, as these players are the club's future. So, many, many thanks to all who took time out to play on the day.

The Toowoomba Pairs and Teams event was also near full capacity with fifty-four pairs and twenty-six teams competing over the three days. Once again there were many visitors, with over half of the players from visiting clubs.

In the Pairs, the best Toowoomba performers were Val McClement and Eileen Josey. They were placed third in the Championship as well as winning the trophy for the Highest Ladies Pair and the Highest Toowoomba Pair. The Pairs event was won by a Sunshine Coast pair, Adrian Mayers and Stephen Brookes. Second place went to Eileen Li (QCBC) and James Evans (Ipswich). Another Toowoomba pair who performed really well was Pat Penberthy and Merna Atkins, who won the morning session.

The Teams event was of a very high standard, including players such as Tony Jackman and Richard Wallis. The best performing Toowoomba team was the Snook Team, consisting of Chris Snook, Pat Larsen, Liz Zeller and Alison Dawson (QCBC), finishing in fourth place overall. Well done.

#### TEACHER TRAINING PROGRAMME

I recently received an email from Joan Butts from the Australian Bridge Federation advising that she will be doing 4 Teacher Training programmes this year, for anyone interested in teaching bridge or running Help with Play sessions.

The Queensland session will be held in Brisbane on July 16th and 17th.

These courses are 9 hours long, and consist of 6 hours on the first day, and a workshop with a real class the second day, given by Joan, followed by a one hour discussion with the group. The course concentrates on the methodology of teaching bridge, and aims to help teachers move towards being the most professional they are able to be.

### **Car Park Extension**

At last we have been able to lodge with the Toowoomba Regional Council the engineering plans and amended landscape plan plus a cheque for \$2,997 plus numerous council completed forms and paperwork.

Hopefully we will obtain a partial refund of up to \$1,000 from the Council Community Fund Application that has been submitted.

Quotations have been received from two paving suppliers for the supply and laying of the pavers, plus the soil fill and grass seeding. The grass removal, earthworks and concrete works will be a separate contractor, but quotes cannot be called until Council has approved the plans.

We hope a start can be made by early June.

# Auction Etiquette: a personal view!!!

We all enjoy our Bridge, but we must ensure that partner and opponents enjoy their time at the table; they too came to enjoy themselves. This is where etiquette comes in, both its normal social aspect and additional aspects pertinent to Bridge. At the table, social aspects must bow to the additional requirements of Law 74. This treats aspects of conduct and etiquette, both socially (Law 74A.1, A.2) and specifically to behaviour at the table (Law 74A.3 to C.8). In summary: yes, be polite and respectful but refrain from chatter, reaction and other acceptable social behaviour during the auction and play; there is time for that when the cards are in the board.

The overriding principle of the required formality is stated in Law 74A.3: "Every player should follow **uniform** and **correct** procedure in calling and playing" (my bolds). Departure from required formality might be seen as giving **unauthorized information**. Without going into details, Law 16, especially Law 16B.1(a) makes conveying unauthorized information unacceptable.

Only issues relating to auctions will be discussed, under the headings of (a) general aspects, (b) auction protocol, (c) bidding methodology and (d) tempo. Written silent bidding will be assumed, which we generally encounter at clubs and congresses. In no ways will be complete, and others would write it very differently and even at greater length.

**General Aspects.** We should treat partner, opponents, and the Director with respect. We show this by being courteous and attentive (Law 74A.1&2;B.1;C.6) – natural characteristics of most individuals. Yet, as humans, some of us lose control in the heat of the moment in a difficult hand.

**Auction Protocol.** Firstly, it is **silent**; there is no need to speak except either to alert partner's call or to describe a bid on the request of the person next to call.

Refrain from comment (Law 74B.2), keep them till after the auction and play. Admittedly some auctions can take unusual turns, or become

amazing or are utterly bizarre; but do not comment or react till later.

What ought never occur is a preface to your written call – whether spoken or indicated by body language. "I don't know" or a similar phrase is often heard before or when a call is written; the truth is that even top players are never entirely certain. Do not writhe in your seat before or when writing a call, nor have your pencil hover close to the bidding pad, remove it, to return it to hovering pattern. Yes! You do want to make the right call. So please consider what it is to be, then make the call decisively and purposively. Do not emphasize your indecision: you have already indicated it by stopping to think.

Comment, preface, action or addition –verbally or in body language- during the auction is unwarranted; neither are shows of approval or disapproval of an action (Law 74 C.2) nor is glaring at partner or opponents (Law 74C.5) acceptable.

**Bidding Methodology.** One ought to be uniform and correct in written bidding. Calls should conform as follows; they should:

- be written in successive boxes, starting in the top left of your section of the slip.
- if a bid, it comprises a number (1-7) and NT, S, H, D or C.
- occupy the best part of the box.
- be within the box, so as not to confuse what may be written in other boxes (whether they might be used or not).
- be written clearly, neatly, in even tempo, and in a way showing it is your chosen call.
- have no flourish in action or in the writing.
- use a consistent font Roman capitals.
- be written with even pressure throughout auctions (not faint nor bold nor variable).

In other words, aim to be uniform (Law 74C.1) with respect to what other players generally use – although we all have our idiosyncrasies (but keep to it uniformly) ... and I know that the bidding slips do not remain still at times.

**Tempo.** Tempo involves even progression of calls in the auction, *i.e.* the uniformity of Law 74A.3, C.7. Calls should be made with neither

delay nor haste (unless the table has agreed to catch up with play). Slowing of the auction's progress may be seen as hesitation; a long halt is certainly hesitation. Hesitation followed by a pass falls into the realm of conveying "unauthorized information". The hesitator conveys the idea that there was something to think about; the pass, however, gives no clues as to what was in mind. We may be distracted by other thoughts (is it time for afternoon tea?), however, while involved in the auction (or play) we ought to show respect to the other players at the table by concentrating on proceedings.

What can happen after a hesitation is partly illustrated by situations in which I often find myself. One of my usual partners will regularly hesitate. He knows that his hesitation might restrict my options in the auction; so if his hesitation is obvious, he will often relieve any restriction on me by making a bid. None-theless, he has hesitated. However, were he to pass and I felt that I have a bid in my hand that I wish to make, I will call the director, report my partner's hesitation and tell the director that I wish to reserve the right to make a bid; and if I bid, firstly: I would require better values than if I bid after partner's in-tempo pass, and secondly: opponent are entitled to appeal at the end of play if they feel that my bid disadvantaged them. Regardless, if there is an agreed hesitation, it is best to call the Director.

**Conclusion.** When I have to look at other player's cards (violation under Law 74C.4), I will cease to enjoy Bridge and I will give it up. But in preparing this article I found that a thing I often do (folding my cards) is a procedural violation under Law 74C.6), which says it shows 'an obvious lack of further interest in a deal'; I had not thought of it that way. And then I often lay them face down on the table – an even worse violation? Despite this, it is never my intention not to play a hand out unless claimed or conceded, and I never complain about poor cards; good cards overcomplicate one's life: they require extra attention!

So follow uniform and correct protocol in your auction (and in your play); enjoy your Bridge; let others enjoy theirs too. And avoid visits by the director to your table to redress issues arising from failure to follow the required auction etiquette; but if you break the rules of

uniform and correct calls and play, by all means call the Director.

Perhaps we all ought to take some of these issues on board and think more carefully about what each one of us does. I plan to do so.
