Treasurer's Report for March 2025


Current assets held as at 31 March 2025:-

Dennis Lincoln



I learnt the art of card play well over 80 years ago; I was my father's banker and was allowed to keep every silver threepenny piece that was won. Brought up in rural Norfolk, took the tractor at age eight to feed the cattle. I was poacher, game keeper, and naturalist at heart. Failed everything at school, except maths! My first job and the only one for which I qualified - farm labourer at 4 pounds 15 a week.

Night school and agricultural college followed, where my visual memory got me my first bit of silver ware, because I still had to overcome my dyslexia and learn to write. I had escaped from the tyranny of the land and was now the first of the family to ever set foot in a University. In 1960 entered the University of Nottingham as a "mature

student" and set out to specialise in animal physiology, where, within the college fraternity, I learnt the elements of bridge. Then on to Cambridge to study for a PhD in neuroscience in the Veterinary Faculty. I was shell shocked by what I found, everyone had a public school education. I had no education, yet nothing to lose.

Two years later I had not only survived but achieved the rare distinction of winning a Fellowship to Corpus Christi College - a Cambridge Don - eating at high table with the world's elite, allowed to walk on the hallowed turf, and gifted a Master of Arts degree. So, for the third year of my PhD I had a salary, sported a large US research grant and employed my own Australian secretary. And played bridge in the Masters Lodge with Sir Frank and Lady Lee. That taught one to count, because the Master had been one of the Heads of the UK Treasury in the post war years.

To cut a very long story short which include 25 years heading up medical research from Scotland to Australia. I was not an academic in the normal sense. Research was a voyage of discovery, a business, set in the medical world of women's health. (I cherish my Scottish title "Honorary Professor of Medicine" University of Edinburgh, and its 250 years of medical history). Retirement to the Garden City in 2006.

Pam and I joined the Toowoomba Bridge Club in 2018. You don't need lessons, just a partner who is a good player of the cards and a common hymn sheet. Though I have been told when I add something of my own creation, it makes our system a Brown Sticker. Current ambition goal - "Life master" with a small m. Still active as I now head for 90. Still going to the gym three times a week and four hours of garden graft every day, the big stuff, tree work and landscaping. Still a valued tradie: carpenter, bricklayer, plumber, electrician and cook, though not so hot on the latest phones, internet streaming and security, and the use of apps. **Dennis Lincoln**



Balancing on a Seat?"

I have mentioned previously that the Laws of Duplicate Bridge prescribe the initial seating arrangement of players. See my newsletter articles from March and April 2024 for the consequences of unbalanced seating arrangements.

Law 3 states that "Four players play at each table, and tables are numbered in a sequence established by the Director. He designates one direction as North; other compass directions assume the normal relationship to North." We see this happen as the Director (or their assistant under instruction) puts the numbers out on each table. You all know that I prefer tables to be in rows so that it is easier for players to follow, and some Directors prefer other arrangements to make board movement easier. Either way, the Director is choosing the numbering, not the players.

Law 5.A states that "The Director assigns an initial position to each contestant (individual, pair or team) at the start of a session. Unless otherwise directed, the members of each pair or team may select seats among those assigned to them by mutual agreement." In congresses and similar major events, the initial seating is predetermined and displayed, and players follow the Director's instruction. For social/duplicate bridge sessions, the Director will often allow the players to choose their own seating but reserve the right to move players if necessary. These movements may be to relocate the tables/table numbers or may be to distribute the playing strength between NS and EW.

Whatever the reason, if the Director tells you to move then you must follow the Directors instruction with good grace (the nice behaviour, not the restaurant in Kenmore). The few minutes before the start of a session are usually hectic, especially on Mondays and Wednesdays, which is why we ask that all players arrive and be seated 15-minutes before start time. This give the Director time to determine the most appropriate movement, and to scan the room to make sure that the field strength is reasonably distributed. What we want is a similar number of strong players sitting NS and EW, same for mid-strength players and same for relative beginners. On average this works out well, but not always. If you arrive late, then you'll probably end up getting whatever seat is left-over.

It is a general trend in all bridge clubs that stronger players tend to sit NS, sometimes because that is where they prefer, sometimes because they are the Director, sometimes because they have been playing a long time and have limited mobility, sometimes because the other people at the table want to avoid using the bridgemates, and sometimes to avoid having a sit out.

We can all make it easier for Directors to "balance" the field, by not setting up camp in the same seat each week. Sometimes sit NS, sometimes sit EW, sometimes sit in the corner, sometimes against the window, etc. Even better, is if you start at a table with players of similar strength as yourself (because this then makes the NS and EW fields a similar strength).

Directors will be encouraging you to do this over the coming weeks. Cheers Chris

4-Mar-25 The ABF Board have decided to stop issuing the physical paper registration cards and ranking certificates. Instead, the Board will investigate a digital solution instead.

The Centre will continue to issue the paper ranking certificates whilst stock lasts. But the registration cards will immediately cease being printed and mailed to clubs.

In the March update when we normally print the 30000+ registration cards that will not happen this year. We hope to have a digital solution in place by then, but it is possible there might be a short delay. Rest assured we are progressing a solution as fast as possible.

Masterpoint Secretary's Report

In April, I processed results for 37 sections from 29 sessions yielding 101.96 green and 24.00 gold masterpoints. There are a further 98.40 gold points from the Wednesday GNOT heat that have been submitted and are awaiting approval (the cutoff is the end of the month, so we might have to wait).

Winners are Grinners

The "Monthly Winners" are recognised as the "individual" winner of <u>eclectic</u> multi-session events. These events combine of all the green masterpoint sessions in a month that have not already counted toward a competition. If there are three available sessions then your best two scores are counted (shows as 2/3), if there are four available sessions then your best three scores are counted (3/4) and if there are five available sessions then your best four scores might be counted (4/5). If there are two available sessions, then they are treated as an eclectic event (best 2/2). If there are five days in the month, then we usually combine two of these (see the bridge diary) as a "Two-Weekly" and additional masterpoints are awarded to the top half of those whose partnerships played both days. The remaining three days are scored as an eclectic with (2/3).

Date Claimers

Joyce Benson Pairs:

- Wednesday Afternoons 7th, 14th & 21st May for red masterpoints. Played in two sections (Open and Novice) over three weeks. First week is a qualifying session, and the top 12 pairs will advance into the Final that runs over weeks two and three. Those not in the final will play in regular walkin sessions over weeks two and three.
- Teams of Three: Saturday afternoon 10th May.
- Australia-Wide Novice Pairs: Monday Afternoon 26th May. Play the same boards as about 500 pairs around Australia receive a detailed commemorative booklet discussing the hands that you play. We will also be running our regular Open section.

The following article is a repeat of one from the April 2024 newsletter. You can claim to win the remaining tricks or to concede them. But there is a process, and players do need to give their opposition time, to evaluate their line of play.

Plus if you concede, your partner does have some rights if he/she doesn't agree.

HOW TO CLAIM OR CONCEDE TRICKS CORRECTLY

How many times have you found yourself in the following situation. The opposition claim the rest of the tricks saying "the rest are mine" and they wave their cards in the air. You are hardly given time to look at their hand and if you query their claim, you are made to feel stupid because you couldn't work out their line of play in two seconds. And unfortunately, it is not the beginners who do this, but the more experienced players who should know better.

It is not being clever or showing off when someone claims. It is a courtesy to the other players when you know you have the rest of the tricks. This saves the opposition the anguish of trying to determine what cards they should keep when really, it is not going to make any difference what they keep and speeds the game up Anyone can claim. Declarer or either one of the opposition. When a player claims, it is illegal for play to continue. The person claiming must face their cards on the table and state the proposed line of play. If one of the opposition dispute their ability to win the remaining tricks – the Director must be called and the person claiming cannot now add anything or change his original statement.

- There is a sound reason for this: once a player hears his claim queried, he realises that there may be a problem and will adjust his play accordingly. When the Director is called to the table on a disputed claim, the Director will first require the claimer to re-state his statement of claim and will then have all four hands faced. The director then hears opponents' objections to the claim.
- For example, If there is an outstanding trump and it seems likely that claimant has forgotten about it, then he will lose a trick to that trump if he can do so by any careless play, eg. cashing side suit winners without drawing the last trump. The Director would need to be convinced that the claimant knew there were trumps outstanding before allowing trumps to be drawn.
- If only trumps are left, they must be led from the top down. If cross trumping, claimer is required to trump from the bottom up. Claimer may over-ruff if the opposition have ruffed prior to his turn.

When you claim, the opposition must be given time to see your cards and evaluate your line of play. This is particularly important when you are playing against newer players


.CONCEDING

There are similar rules when a player concedes the rest of the tricks to the opposition. Once again play must cease. However, if you are defending and your partner concedes the rest of the tricks, you have the right to say that you are not agreeing to the concession if you feel you have a trick in your hand. Unfortunately, in this situation you have alerted Declarer to the fact that there is a possible loser still outstanding.

I was taught a very valuable lesson by Ivy Dahler years ago about claiming. I was playing a Small Slam against her, put my cards down and said, "the rest are mine" and didn't state my line of play.

Well, according to Ivy, because I didn't say how I was going to play my hand, Ivy said "I will tell you how you are going to play the hand".

Whether this was strictly legal, is a moot point – but of course I ended up going off big time. Glerys

Session Rules Reminder

- Players should be <u>seated</u> 15 minutes prior to the start of play for a session.
- The Director makes the final decision on seating arrangements and on playing arrangements in the room (e.g. windows, air-conditioning).
- Only **green** and **blue** systems are permitted in club events.
